 The CBT will consist of questions in objective type, 10% of the marks on Official Language will be on optional basis. Totally 110 question will be asked out of which 100 question only to be attended.

Those who are eventually considered for posts as JE (Works) have to undergo 12 months training. During the period of training, they will enjoy the same privilege

and status of category from which they are selected.

3. There will be no supplementary written examination for the above selection.

4. Last Date for submission of application to the Supervisory Official is 21.02.2025. Application from eligible volunteers in the prescribed proforma will be collected by the Supervisory Officials and sent in one bunch with a covering letter (showing the names of volunteers) to reach the undersigned on or before 25.02.2025. The office copy of the covering letter should be kept on file at the unit for future verification when needed.

Applications received after the last date prescribed will not be entertained.
