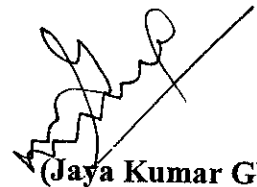

3.	Sr. Account Assistant	GP 4800 & Level -8	Sr. Accountant (I)

2. The revised designation will not entail any change in classification of posts as Group 'C', their pay levels, method of recruitment, existing duties, responsibilities, seniority and avenues of promotion.
