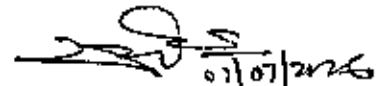

(A) *sub-rule (3) of Rule 902 of Chapter 9 of Indian Railway Establishment Code (IREC) Vol. I, shall be substituted, as under:-*

(3) *"Controlling Officer" shall mean in relation to the level of subscribers specified in the second column of the table below, the officer or authority specified in the third column thereof.*
