The General Secretary, AISCTREA/SZ has submitted the subjects of AISCTREA for the informal meeting. The following are the subjects.

11	<p><u>EQUAL PENSION TO SHRI SILAS VIJAYAKUMAR ON PAR WITH HIS JUNIOR SHRI. K. NATARAJAN.</u></p> <p>Shri Silas Vijaya Kumar, Retd.CTTI/MDU is a Senior Citizen aged about 97 he was appointed on 16.11.1950 and was drawing pension of Rs.7674/- from 01.01.2006 and, instead of his junior was appointed on 16.12.1968 and drawing more pension of Rs.14000/- from 01.12.2009. So in order to get equal pension, instead he filed a case No. 6373/2010 to squash the seniority list dated 01.12.1983 and 01.06.1986, for which on 20.01.2011 dismissed instead of his case under bar of limitation in against AIR 1997 supreme court 27 from CAT, New Delhi in Civil No 9489 of 1996 (artising out of SLP (c) No. 20181 of 1993 dated 19.07.1996 pronounced by honorable judges Dr.A.S.Anand and Shri K.T. Thomas observed " Constitution India Art 311- retirement pensionary benefits, claim for payment toward encashment of leaves, certain increment arrears etc., bar of limitation- cannot be pleaded by Govt. of India when department itself had defaulted in making payments promptly in spite of demands consistently made by employee department directed to pay 2 lakhs towards interest and compensation and litigation expenses in addition to claim amount. So he most earnestly implore your honour, he to cancel the dismissal order dated 20.01.2011 in No 6373/2010 and to pass necessary orders to get equal pension on part with his junior No 6373/2010 and to pass necessary orders to get equal pension on part with his junior Shri.K.Natarajan, and Shri.P.Silas Vijaya Kumar belong to one and the same category and in grade.</p>

Honorable Tribunal declared in 2nd para in OA No 901/1997 that the applicant was also entitled to personal Pension of Rs.112/-. Twice sanctioned by Tribunal as per ministry's letter dated 27.06.1985, payment of personal pension has to be continued as per special provisional for those retired between 01.01.1986 to 30.06.1987, but payment personal pension was suddenly stopped on 01.01.1988 without any prior notice is against CCS pension No.70. It is further seen that the respondents are relying on wrong documents to deny the legitimate personal pension to the applicant was observation made in the 8th Para on 06.08.1999 in OA 901/1997.

In this case, the following grievances is bringing to you for consideration and necessary favorable orders: -

1. To grant equal pension of Rs.14000/- on par with the pension of Shri. K. Natarajan from 01.12.2009.
2. After completion of one year from 01.07.1985 to 30.06.1986, he retired on 30.06.1986. So, notional increment may please be granted.
3. Payment of personal pension suddenly stopped from 01.01.1988 may please be continued for payment as per observation made in 8th para on 06.08.1999 in OA 901/1997.
4. Encashment leave on half average pay though represented during 2000, 2001 and 2002 pension Adalats, denied payment. It must be paid along with LAP on the retirement date.
5. Payment of calculation particulars may please be supplied to him.

DENIES/DELAYS THE RIGHTS OF THE SC CANDIDATES IN THEIR PROMOTIONS OF LOCO RUNNING STAFF OF MADURAI DIVISION.

The Administration published the selected list of LP/SHG-II on 24/08/2023, for 29 vacancies (UR-20, SC-05, ST-01) and issued the promotion order on 08/09/2023 for 13 UR vacancies, but no one SC got promotion. Here also the reservation in promotion for SC candidates was not followed and till now 05 SC LP/SHG-II was not filled. But, 3-4 UR category junior most ALPS are officiating as LP/S against the SC vacancies.

This practice will be immediately stopped and to restore the original vacancies in favour of the SC candidates.
