- 29. Casual Labour with temporary status are entitled to get 4 sets of PTO till their absorption.
- 30. Revision is not one-time exercise and there is provision for a second revision of the case.
- 31. A non-gazetted Railway Servant cannot seek a personal hearing from the Appellate Authority in cases of certain penalties.
- 32. Reduction in pay will affect a Railway servants' position in the seniority list
