Railway Board vide letters cited at reference (1) and (2) has instructed for conducting "Swachhata Abhiyan" (Cleanliness drive) as part of the Independence Day Celebrations-2025 in two phases from August 1<sup>st</sup> to August 15<sup>th</sup> and from August 16<sup>th</sup> to October 31<sup>st</sup>, 2025.

- 1. In the first phase of the drive, scheduled from August 1<sup>st</sup> to August 15<sup>th</sup> 2025, the focus shall be on ensuring cleanliness within and beyond railway platforms and stations, along with the removal of garbage from railway tracks, particularly in municipal areas, as instructed vide letter under reference (i). An interim report on the activities conducted during this phase, along with supporting photographs and details of the activities, may be submitted to this office by 15/08/2025.
- 2. In continuation of these efforts, the Swachhata Abhiyan activities to be continued into the second phase from August 16<sup>th</sup> to October 31<sup>st</sup> 2025. During this phase, special emphasis shall be placed on maintaining cleanliness in trains, railway stations, and other railway establishments, as per letter under reference (ii). An interim report on the second phase, along with supporting photographs and activity details, may be submitted to this office by 31/10/2025.

A detailed program of activities for both the phases of the drive has been outlined and enclosed herewith for implementation. All Divisions/ Workshops/ Offices/ Other units are requested to take necessary action in line with the guidelines provided above and follow the indicative list of activities as given in enclosure.

## <u>Cleanliness activities to be undertaken for Independence Day Celebrations</u> **2025**

#### (01.08.2025-03.08.2025)

- Swachhata pledge should be administered to Railway Staff and their families.
- Swachh Raths/Prabhat Pheris should be taken out in the morning with the slogan "Swachh Rail Swachh Bharat" with a view to raise awareness among public especially railway employees and their families to ensure cleanliness in the vicinity of their habitat.
- Nukkad Nataks be organized with the help of cultural teams of Railways, NGOs, social organizations and School children at railway stations for awareness of passengers.
- Workshop and training programs should be conducted by EnHM officials for staff having public interface.
- Creation of selfie booths on Swachhata theme at stations and other appropriate locations.
- Mass awareness activities on Swachhata theme.

#### (04.08.2025- onwards)

- Efforts for a combined shramdaan in Railway premises & nearby locality, engagement of local celebrities/influencers should be done for cleaning the station premises and its surroundings. (Care should be taken to ensure safety while working on/near tracks without hindering the operation of trains)
- Cooperation of passengers be sought in keeping the coach and stations clean through PA system on the Railway Station and announcements in trains. They may also be encouraged to take Swachhata pledge through pamphlets.
- Organize workshops on Sanitation and upkeep of railway stations by involving NGOs, Charitable institutions, Scouts & Guides, Unions and all employees to undertake cleanliness drive on their nearest railway stations.
- Workshops should be organized on Sanitation and upkeep of Railway Colonies/offices and other Institutions on Railway premises.
- Cleanliness awareness campaign to be organized on proper use of bio-toilets.
- Anti-littering notices to be displayed in all institutions on the Railway premises like Railway Colonies, Offices, Railway Stations, Rest Houses and Dormitories, Running Rooms, Hospitals and Health Units and Schools.
- Organize intensive cleanliness drive at Railway stations.
- Intensive cleaning of tracks near entry and exit points of cities in collaboration with Urban Local Bodies, as per requirement.
- Availability and working of cleaning machines, tools & plants, protective gears for cleaning staff must be ensured.
- Adequate provision of dustbins at stations is to be ensured. Separate dustbins be provided at stations for segregated collection of waste.

- A campaign for 'use the dustbin', 'donate the dustbin' may be taken up to generate the awareness among the rail users.
- Cleanliness of drains & toilets to be focused. Inspecting upkeep and stacking of hydrant pipe in proper manner.
- Divyang access to the toilets be ensured in the station area and Railway Offices and buildings.
- 'Swachhata Hastakshar' campaign may be launched with participation of passengers.
- Intensive cleaning of all Building, colonies and offices.
- Use of plastic to be discouraged. Stations should be made plastic free.
- Plastic bottle crushers should be properly working and passengers be encouraged to use these machines so that plastic thrown does not choke drains or water outlets.
- All efforts should be made to ensure that all railway platforms be litter-free.
- Segregation of waste should be encouraged by setting up of separate dustbins.
- Health checkup camp be organised for Swachhata workers.
- Intensive cleaning of canteens, food stalls in and around station premises should be undertaken.
- Utensil cleaning, garbage disposal in base kitchens, pantries and food plazas
  at stations also to be checked during cleaning for sustainable improvement in
  cleaning activity. Food vendors, cooks and bearer of canteen to be covered
  under cleanliness, medical checkup and hygiene.
- To conduct Inspection of Pantry Cars by team of officers and staff and propagating awareness on cleanliness & hygiene among pantry car staff.
- Cleaning of water bodies in Railway premises. All water treatment plant, water installations including filter plants, for pre and post filtration quality of water.
- Awareness campaign for protection of environment.
- Observe tree plantation drive on Railway land/colonies.
- Shortlisting of better performing Swachhata worker of campaign to be finalized by 13.08.2025 and suitably rewarded at the culmination of the event, on Independence day.

# Cleanliness activities to be undertaken from 16th Aug to 31st Oct, 2025

- For Swachhata Pakhwada celebrations, activities as per Board's letter No. 2025/EnHM/08/01/Sw. Pakh. dated 16.04.2025 be followed.
- Intensive cleaning of toilets, vestibule area, inside and outside cleaning.
- Inspection of distribution/cleanliness/storage of linen in trains
- Special drive for Pest and rodent control in trains jointly with IRCTC.
- Review of working of Clean Train Station (CTS) scheme as per Board's latest
- Do/Don't posters for passengers regarding cleanliness, anti-littering to be ensured in coaches wherever not available.
- First chamber cleaning of bio-toilets.
- Intensive inspection/Cleaning of trains at washing lines by team of Supervisors/Officers in primary base rake and stabled rakes.
- Cooperation of passengers be sought in keeping the coach clean through PA system on the Railway Station and announcements in trains.
- 02 days special drive on OBHS counselling for better passenger interaction.

Note: All trains have to be inspected in the washing lines, in railway yards and also at stations. Train inspections to include checks on toilets and quality of linen. Suggestions/feedback should also be obtained from passengers and immediate action initiated. Drive Report to be submitted by each team of officers/supervisors with

- To organize intensive Cleanliness drive at stations.
- Cleaning of surrounding area around stations.
- Availability and working of cleaning machines, tools & plants, protective gears for cleaning staff must be ensured.
- Adequate provision of dustbins at stations is to be ensured.
- Ensuring that separate dustbins have been provided at stations for segregated collection of waste.
- Inspecting upkeep and stacking of hydrant pipe in proper manner.
- Use of plastic to be discouraged. Stations should be made plastic free.
- Plastic bottle crushers should be properly working and passengers be encouraged to use these machines so that plastic thrown does not choke drains or water outlets.
- All efforts should be made to ensure that all railway platforms be litter-free.
- Segregation of waste should be encouraged by setting up of separate

- To organize and Conduct Intensive cleaning to clean and improve cleanliness in Railway colonies, offices, Retiring Rooms/waiting halls, Rest houses and dormitories, etc.
- Plantation of tree and landscaping in the premises to be undertaken for beautification.
- Provision of Dry and Wet Dustbin should be made available.
- Intensive drive should be undertaken to clean up garbage in Railway Colonies and other Railway establishments. Provision of dustbins be made.
- Participation under CSR be called for installing Bio Compost facilities at Railway Colonies, Stations Hospitals, Workshops etc.
- Focus on cleanliness of railway track located in station adjacent areas.
- Intensive cleaning of garbage from the sides of Railway tracks in collaboration with Urban Local Bodies.
- Intensive monitoring of nominated garbage points and its updation at CMM portal.
- Special passenger awareness drive to dispose of garbage in dustbins provided in trains and not to throw garbage along the tracks.
- Besides removal of garbage, unwanted bushes/grass may also be cleared.
- Intensive cleaning of canteens, food stalls/plazas in and around station premises should be undertaken. Utensil cleaning, garbage disposal also to be checked during cleaning for sustainable improvement in cleaning activity.
- Food vendors, cooks and bearer of canteen to be covered under cleanliness, and hygiene rules.
- Provision of Dry & wet Dustbin to be made available.
- 02 days special drive for intensive cleaning of Pantry cars.
- To inspect Base kitchen and its Store area for cleanliness and hygiene.
- Provision of compactors i.e. smart bins in Pantry Cars to be encouraged.
- All water treatment plant, water installations including filter plants, for pre and post filtration quality of water.
- To check for cleanliness and hygiene maintained at Filtration Plants.
- To conduct Drive for making Drinking water Tap area clean at Stations.
- To educate staff to ensure proper stacking of hydrant pipes at coach water filling points (at Stations & Coaching depots) to ensure hygiene.
- To conduct intensive inspection of all water installation in offices, Railway Colonies/Hospitals/Health Units/Schools.
