Candidate shall carefully read the instructions given below, and follow them scrupulously. Failure to comply with the instructions may lead to cancellation of the candidature.

- No candidate will be allowed to enter the test center after gate closing time.
- The duration of CBT will be 120 minutes for answering 100 questions out of the 110 questions including 10 optional questions on official language policy and rules.
- The candidate can view the question paper in Hindi & English languages and answer the questions. For interpretation purpose English version will prevail.
- 4. There will be negative marking for wrong answers. For every wrong answer, 1/3rd mark will be deducted. Candidate should also write his/her name and Roll Number on the Rough sheet(s) provided for rough work. The Rough sheet(s) will have to be returned to invigilator after the test.
- Candidate is required to report on the allotted CBT Centre/Venue, on the allotted Reporting Date & Time as mentioned on the front page of his/her call letter.
- 6. The candidate shall obey the instructions issued by the railway officials at the CBT venue. The candidate is also advised to maintain discipline during CBT, for smooth conduct of the CBT.
