

In terms of provisions of Section 22 of Final Modalities, the SBEC has approved following modifications in the 'Final Modalities':


**I. Period for Filing of Nomination by contesting Trade Unions:**

### III. Campaigning by elected public representatives:

In the Final Modalities, Section 6.5.7 is replaced as under:

“6.5.7 Campaigning by elected public representatives is not permitted except in following cases:

- (a) Those holding post in contesting Unions;
- (b) Those holding post in National Federations or Central Trade Unions to which the contesting Union is affiliated;
- (c) Those who have been Railway Servant.”

### IV. Revised polling dates for Metro Railway, Kolkata:


In page 8 (Detailed Election Schedule) of the Final Modalities dated 9.9.2024, Serial No 14 & 15 are replaced as under:
