Sub: Dispensing with the manualy filled Pension Application forms and Annexures It is understood that the retiring employees are being asked to fill the pension application forms and annexures manually despite the same forms are being already filled in HRMS by them citing the same is being insisted by the Accounts Pension section. This practice may create a situation where the details as in forms filled in HRMS will be in variance with the manually filled in form and invite issues at a later date.

To avoid this, it is advised that the practice of the manual filling of forms to be dispensed with immediately and the forms that are available in HRMS to be downloaded, printed out and signed by the retiring employee instead of the manual forms being filled and signed now.
